<u>CALL TO ORDER:</u> The Board of Directors meeting was called to order at 3:00 p.m. The meeting was held inperson and via a web-based platform where all participants could hear and participate. All participants introduced themselves.

RJ Gillespie introduced Valdez Bravo as the Board member from Multnomah County.

#### **COMMITTEE AND CAC REPORTS**

The Board heard reports from each of the Board Committees and the CAC.



<u>Governance Committee:</u> Bob Stewart reported on the approval of new SDOH workgroup, executive session to discuss possible board member candidates, and the committee's discussion regarding the change of control of CareOregon. The committee's goal is to have resolutions before the Board for the November Board meeting.

**Quality Committee**: Candice Jimenez reported the Quality Committee did not meet last month.

<u>Community Impact Committee</u>: Bettyna Rosales gave a community impact report. The committee heard a presentation on the SHARE plan and guiding principles. Additional information was shared information about the housing benefit pilot program and on community engagement sessions.

<u>Finance Committee:</u> Eric Hunter reviewed Health Share finances and the 2022 Medical Loss Ratio. Eric reported for 2023 all organizations are performing well. The committee also discussed the global budget.

<u>Community Advisory Council:</u> Abigail Lawrence reported that the committee reviewed guidelines for SHARE investments with community partners, and final funding and an update on a stipend request for committee members. The committee also discussed recruiting new members.

**RSHIF**: No meeting.

**CEO REPORT:** Mindy Stadtlander reported on the governor's OHA director search. Mindy reported Health Share is getting close to the health-related social needs benefit and will go live January 1<sup>st</sup> for climate related benefit. The OHA is implementing justice-related eligibility in 2025. Health Share has made an offer for a new COO. A task force was convened by the governor to work on downtown Portland housing.

#### **CONSENT AGENDA:**

RJ Gillespie introduced the consent agenda items and offered the opportunity to remove or correct any item from the consent agenda.

#### **LEGACY-OHSU BREIFING**

Jeff Conklin provided an update that the matter is expected to be a long process but both organizations think the combination will be good for the community. The parties have signed a nonbinding LOI. The first steps will be due diligence and regulatory review.

#### REINVESTMENTS TO IMPROVE ACCESS PROGRESS REPORT

Maggie Bennington-Davis, Robin Henderson, and Melissa Eckstein presented on three highlighted investments, including Social Emotional health, Tri-County Urban Heat Island Mapping Project and Ecosystem Analysis including substance use disorder, mental and homelessness.

- <u>Social Emotional Health</u> will be a \$2M investment with 4 contract awardees and will focus on connecting children with social and developmental health needs with resources so that they can be ready for kindergarten.
- <u>Heat Island Mapping</u> will identify members at risk during climate events based on clinical diagnosis and is a new area for HSO.
- <u>Ecosystem Analysis</u> includes a \$40M investment with priorities for care navigation and coordination and increased access to services, with a estimated \$206M gap in needed investment. The analysis also identified future strategic focuses and 2023 accomplishments. The analysis is underway and ready to being capacity modeling once funding is available.

#### **ECOSYSTEM ANALYSIS**

Graham Bouldin and Andy Mendenhall provided additional Ecosystem Analysis information for analysis of member demographics and utilization patterns for seven cohorts of HSO members with



mental health and substance use disorders.

#### ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Health Share of Oregon (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

# **Getting paper copies**

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

#### Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

#### Consequences of changing your mind

# To withdraw your consent with Health Share of Oregon
