The Board heard reports from the Board Committees, the CAC, and RSHIF, along with an update on the CHEW/Equity.

Quality Committee: RJ Gillespie reported on the work of the committee including committee charter review and update, discussion of incentive metrics (including the presentation today), and how to address any gaps in social emotional health action plans.

Community Impact Committee: No report.

<u>Finance Committee</u>: Eric Hunter reported on the information provided to the Board including upcoming redeterminations (and the impact thereof), and MMLR tracking.

<u>Community Advisory Council</u>: Abigail Lawrence reported that the CAC had discussed recent Health Share staffing changes, as well as the ongoing use of equity tools in Health Share's work.

<u>RSHIF</u>: Abigail Lawrence reported that RSHIF is interested in changing its name to better reflect its work. She discussed the five of eight populations now being served, the number of enrollees and the stable housing being provided. The committee also received an update on housing benefits.

<u>CHEW work group/Equity</u>: Mariotta Gary-Smith discussed upcoming work of the CHEW including its charter and how work is accomplished.

Ebony Clarke joined at 3:26 p.m.

Mariotta Gary-Smith discussed Dr. Martin Luther King's views on health and racism.

<u>CHAIR REPORT</u>: Marni Kuyl discussed Washington County's recent hiring of a new director who will serve as Washington County's representative to Health Share. She also announced that candidates for Chair, Vice Chair and Secretary are being sought by the Governance Committee.

INTERIM CEO REPORT: Mindy Stadtlander, Interim CEO, discussed ongoing work and announcements including the work of Beth Spinning on an interim basis. Mindy Stadtlander also discussed the upcoming legislative session, the work of the FIOC (and the operationalization of that work), upcoming redeterminations, and the optimization of Health Share's current 2.0 model.

Dorane Brower updated the Board on the search for a CEO of Health Share. A task force of Andy Mendenhall, Rod Cook, Jeff Conklin, Christa Shively and Dorane Brower has been formed to identify candidates. The Board discussed the collection of key attributes and providing the same to Dorane Brower for the work of the task force. Those attributes will also be shared with the Board.

QUALITY POOL OVERVIEW

Cat Livingston explained the monthly metric dashboard, the 2023 incentive metrics and how data is used in support of the metric achievements.

Katrina McPherson then discussed the "upstream" metrics and the challenges that they present. Additionally for consideration is how quality metrics funds are invested and the guiding principles therefor.

The directors discussed implications to the current quality infrastructure, the importance of all of the metrics, and how to ensure equity.
