

# **Meeting Recap**

# Community Advisory Committee (CAC)

## June 14, 2023 1:30-3:30pm

## Topic 1: OHA Updates

• Key Takeaway: Rebecca Donell provided a document about PHE ending and what changes will be made to certain authorities and flexibilities. Discussed the Keep Covered campaign that will help people be aware of changes and walk them through what is needed to determine eligibility. Provided links to Keep Covered campaign website that can inform needs. Website also provides opportunities for feedback and to request materials. She provided a links to monthly webinars with updates on OHA information and CAC 101 learning sessions July 17 and 26 and links to register. This will provide overview of CCOs and how CACs work. CHAs and CHPs. She mentioned call for public triage on June 26 and contact information if anyone would like to their expertise. Jamie Zentner explains that public triage document explains how HCP make decisions when they have limited resources. She explained that air quality devices like ACs have been provided to certain folks through health-related services enrolled in CCOs. Going forward these will be Medicaid funded products.

### Topic 2: - Community Health Improvement Plan

 Key Takeaway: Maria explained that our new Community Health Improvement Plan (CHIP) is due in 2024. Maria walked through the journey of various cycles of CHNA and CHIP. In 2018 a vision was created for how we wanted to move forward. CAC members identified priority populations and decided what areas should be focused on. Most recent CHNA was completed by Healthy Columbia Willamette Collaborative (HCWC) in 2022. Partnered with HMA and OHEA and they did 37 listening sessions, 311 community members and 508 online survey responses. Slide were used to show this, and Brendon shared a link to HCWC 2022 report. Maria provided a timeline for CAC presentation, Community CHIP Events, Governance presentation and Board presentation. Presented the guiding values which are strength based, adaptive and aligned. The group agreed that the guiding values should remain the same. Maria discussed the priorities that were surfaced in the last CHIP and it was agreed that focus areas should remain the same moving forward, while strategies may need to adapt or change. It was mentioned that we need to ensure that we have clear definitions on each focus area.

#### Topic 3: CAC Retreat #2 - Preparation

• **Key Takeaway:** Brendon mentioned that he and Phyusin will be meeting with Ana to develop the agenda for the CAC Retreat part 2 on July 19<sup>th</sup>. Brendon reviewed themes and stated the HEET team's commitment to review plus delta from last retreat, provide upfront information and answer questions from first retreat.

#### **Topic 4: Health Share Updates**

- **Key Takeaway**: Phyusin mentioned that HSO is still recruiting for role of Tribal relationship specialist. Currently on round 2 and looking to conduct interviews in July. HSO is working on Board retreat and working to bring in leaders to help give thoughts on where they think HSO should be headed.
