Meeting Recap

10/11/2023, 1:30-3:30pm

Topic 1: SHARE Investment: discuss Share proposal ideas from CAC members

Key Takeaways:

- Abigail elevated West and Francisco's **OSCI CHW programing proposal** investing in expansion of culturally specific CHW supports for the Hispanic community to the Tri-County area
 - CAC members noted alignment with building community capacity and expanding access to culturally and linguistically specific services.
- Rachel proposed investment in Family Peace Center Project on behalf of the Family Justice Center of Washington County.- would bring more domestic and sexual violence trauma services for children and youth. The project would increase awareness, access to programming and services. Funding would be used to increase capacity, establish a potential medical center for survivors, and increase programming/operations. Potential to bring in culturally and linguistically appropriate services as well.
 - Broad CAC support for proposal and noted clear linkage to CAC priorities around social connection
- Yamungu proposed **investment in African culturally specific CBOs** that are offering food access, mental health services, gang/gun violence prevention services
 - CAC agreed that food work could be addressed as part of Culturally-specific food access project/expansion
 - No specific CBOs were proposed for mental health/gun violence services (POIC and AYCO were briefly discussed)
 - Yamungu will provide proposal identifying specific CBOs.
- Health Share staff Proposed expansion of last year's Culturally-specific food access investment and partnership with OPHI.
- Lung: proposed a project on Rockwood CDC transitional housing and supports (school enrollment, OHP)
 exit to permanent housing. Hotel shelter (75 rooms).

Themes discussed during proposal consideration:

- Center community need and hold space for the capacity needed to support these proposals

- Should CAC choose one proposal to advance, or all? This is not defined and something for CAC to further discuss and staff will support recommendations.

- Proposals do need CAC consensus to move forward. We are in a tight timeline to submit proposals

- Historically HSO has not directly funded CBOs, SHARE opportunities are fairly new so we want to connect, support and leverage the lens CAC brings into the process

- Proposals will be reviewed from CAC as well as CI MAC/plan partner submissions.

- There are connection points that we can make within current work that is happening to bring in the

different proposals that we can continue to leverage beyond this SHARE process.

- Group review proposal form and required information

Decisions on Proposals to Advance:

- Quality matters more than quantity: how can we align to overall CAC priorities, goals, and strategy centering in Health Share's Racial Equity Commitment.

- Group agreed all proposals align strongly with CAC priorities and should be advanced and we can frame the proposals to thread in language of how these proposals align with the specific criteria, strategies and align with

our goals

- Recommendation approach: CAC members proposing projects can complete Word version of proposal template, then send to HEET team for additional support with language and framing to align with CAC goals, CHIP, etc.

- CAC agreed on this approach and proposal drafts will be sent to Brendon by Mon. 10/16

Topic 2: Redetermination: Community Outreach

Key Takeaway:

- Brendon reviewed organizations that received funding and next steps and asked CAC for feedback
- SACCO, Urban League, IRCO, NWFS, OLHC, Afghan Support Network, We Care, Rockwood CDC, CAP all received funding.
- o Confirmed that funding covers services in Tri-county area

- Brendon reminded CAC members of stipend availability as end of year approaches and offered support with application process to receive a stipend – including individual support as needed to address specific income situations.
